Hawaii's new Procurement Law, Act 52, SLH 2003 (Omnibus Procurement Act, SB1262), has been described as the most important piece of legislation that has come out of this year's Legislative Session. This workshop will focus on the Law and how it will affect the way government does business in Hawaii. Representatives from all of the Counties and major State agencies affected by the new rules will share their insight in the development of policies and procedures, as the regulations are just now being implemented. In addition to our local authorities, key members of National award-winning programs will share their strategies and experiences as they implemented qualification based selection (QBS) processes. The afternoon session will feature a lively interactive panel discussion that will allow the audience to raise issues and provide input to the various County and State officials as they embark on the formulation and implementation of new procedures.
